# GENERAL INFORMATION FIREFIGHTER/ENGINEER (EMT AND PARAMEDIC) JOIN US FOR AN EXCITING CAREER IN THE FIRE SERVICE!

Job Description:

### Minimum Qualifications for EMT recruitments:

Applicants must be at least 18 years old, have a high school diploma or equivalent, and have a valid EMT license (state of California or NREMT), AHA BLS/CPR certification, and CPAT card by the application filing deadline. The applicant must also have a state of California driver's license by time of appointment. All licenses and certifications must be maintained/remain valid through start of the fire academy.

### Minimum Qualifications for Paramedic recruitments:

Applicants must be at least 18 years old, have a high school diploma or equivalent, and have a valid state of California Paramedic license; AHA ACLS, BLS/CPR, and PALS certifications; and CPAT card by the application filing deadline. The applicant must also have a state of California driver's license by time of appointment. All licenses and certifications must be maintained/remain valid through start of the fire academy.

The following certifications may be a minimum qualification for specific recruitments of this classification. If required, it will be indicated as such on the job announcement/posting for the recruitment:

- Firefighter I Academy certification from an Accredited Regional Training Program or an Accredited Local Academy as approved by the California Office of State Fire Marshal/State Fire Training, or;
- Firefighter I certification from the California Office of State Fire Marshal/State Fire Training.

# THE TESTING AND SELECTION PROCESS

When an open recruitment is announced, the job posting will specify the details of the testing and application process. The following is a brief outline of the Department's recruitment process:

- Job announcement is posted. Interested applicants will need to make sure they have a passing score with the testing provider by the testing deadline, and that they've paid the fee to have the score sent to the Department.
- Submit an application on the Department's website.
- Once the Department has determined the applicant meets the minimum qualifications for the position, the applicant will be provided information for the oral board interview.
- An employment eligibility list will be established from the scores.
- Selected candidates on the list will move on in the selection process based on vacancies available, which may include a Department fitness test (EMT and paramedic candidates) and paramedic skills assessment (for paramedic candidates only).

- Selected candidates will participate in the Chiefs' interview.
- Selected candidates will receive a conditional offer for employment with the Department. At this time, a detailed background investigation, psychological evaluation, Livescan fingerprint, and medical examination will be completed.
- Successful candidates will receive a final offer for employment as a Firefighter Trainee with the Department.
- Uniform fitting will take place.
- Fire Academy will begin and will last from 18 22 weeks.
- Once you've successfully completed the Fire Academy, you will begin employment with the Department as a probationary Firefighter/Engineer.

### Information on the Fitness Test:

The current fitness test includes the following:

- Run 1.5 miles in 12 minutes or less
- Pull-ups (palms in or out) 3, or flexed arm hang 45 seconds
- Push-ups (to metronome of 80 bpm) 20
- Curl ups (crunches to metronome of 60 bpm) 30

#### Information on the Paramedic Skills Assessment (for paramedic candidates only):

Candidates will complete two simulation scenarios, and assessments will be based on AHA and NREMT-P guidelines. Candidates will also be tested on EKG reading.

## ADDITIONAL INFORMATION

<u>Physical Standards</u>: Weight in proportion to height in accordance with medical standards. Visual acuity of not less than 20/40 vision in each eye corrected and not less than 20/100 uncorrected in each eye, with only mild red/green color defects being acceptable.

<u>Preference</u>: Current Department volunteers and employees in good standing may be eligible for selection preference by being invited to the oral board if s/he successfully passed the written examination regardless of test score order.

<u>Tattoo Guidelines</u>: Tattoos containing profanity, inappropriate messages and/or images are strictly prohibited.
